JANUARY 2021 MINUTES

The George City Council met in regular session on Wednesday, January 13, 2021, in the Community Room, 115 S Main Street, with Mayor James L. Cuttell presiding. Mayor Cuttell called the meeting to order at 7:00 p.m. The roll was called by Mayor Cuttell. Present were Ande Bruinsma, Stacy Denekas, Warren Tiedeman and Carola Vivian.

Vivian made a motion to adopt the agenda. Tiedeman seconded the motion. All present cast aye votes, motion carried.

OPEN FORUM: Cory Altena, District 3 County Supervisor, gave an introduction as he was just elected to the position and left his contact number.

Council Vacancy Candidates: Dustin Rodger, candidate, gave an introduction and background to the council. Rodger wants to serve and be a part of this great community that we have going for us. – no other comments made.

Vote was cast to select the councilperson to fill the vacancy between the four candidates John Grotluschen, Matt Hilbrands, Nyron Moore and Dustin Rodger. The vote went to Nyron Moore. Thank you to all the applicants for applying and you are all encouraged to apply again and also participate in next election.

Tiedeman introduced the following **Resolution 2021-01-293** entitled RESOLUTION TO APPOINT TO THE CITY COUNCIL and moved that the same be adopted. Denekas seconded the motion to adopt. Roll call vote: –ayes: Bruinsma, Denekas, Tiedeman and Vivian, –nays: none. Motion carried.

Nyron Moore was unable to attend the meeting so he will complete the Oath of Office at the next council meeting.

Fred Landis, Chief, presented the annual report from the George Emergency Medical Service. They continue to maintain a squad of 14 members with 2 students. The GEMS responded to 72 calls in 2020. Due to the unknow with COVID the GEMS have cancelled their annual fundraiser with Dad's Belgian Waffle Breakfast for 2021. GEMS and George Fire Department want to do fundraiser/open house to show off the expansion and this will depend on COVID. In the next couple years, the GEMS would like to upgrade the 2002 Ford Super Warrior Ambulance and they are currently looking into different models, prices, grants and matching funds

Bill Sprock, Chief, presented the annual report from the George Fire Department. They continue to maintain a squad of 23 members. The GFD responded to 25 calls in 2020. George Fire Department hopes this year they will be able to have their annual Duck Race Fundraiser and fireworks show during the 4th of July and this all will depend on COVID. The GFD and GEMS are grateful to the City Council and the Heeren Estate for the opportunity to put an addition to the current fire station to accommodate the amount of space needed for trucks used in emergencies. Sprock asked the council to continue their support of the George Fire Departments work with the Rapid Speedway Racetrack and the renewal contract should be coming in April. The City Council wants to thank both squads for their continued dedication to the City of George. These volunteers go above and beyond the call of duty when needed.

Lois Jurrens, Museum Board chair presented a written annual report and financials to the council.

Fred Landis, Library Board Representative, presented the annual report from the Library. Library staff continue to do an excellent job offering many program opportunities for youth and adults. The library received a Dollar General Summer Literacy Grant and that was used to help purchase ARC program to coincide with the school's reading program. Library circulation of books and non-books continues to increase. They are in the process looking at new furniture to update the "original" furniture and the choice will accommodate a placement in a new building. The board still continues to look all the details of building a new library by searching locations,

funding, grants, blue prints, possibly creating a "Friends of the Library" group. The new book drop box will be here soon and will install at a later date.

Tiedeman made a motion to approve the consent items. Vivian seconded the motion. All

The Oath of Office was administered to Fred Landis who will fill the vacancy as Chief on the George Emergency Medical Service due to the resignation of Sara Sprock.

Denekas seconded the motion to adopt. Roll call vote: —ayes: Bruinsma, Denekas, Tiedeman and Vivian, —nays: none. Motion carried.

Vivian made a motion to approve the Mayor recommendations to the committees. Denekas seconded the motion. All present cast aye votes, motion carried.

Denekas introduced the following **Resolution 2021-01-295** entitled RESOLUTION TO SET THE FISCAL YEAR 2022 MAXIMUM PROPERTY TAX DOLLAR HEARING FOR FEBRUARY 10, 2021 AT 7:00 P.M. and moved the same be adopted. Tiedeman seconded the motion to adopt. Roll call vote: –ayes: Bruinsma, Denekas, Tiedeman and Vivian, –nays: none. Motion carried.

The Mayor will negotiate a renewal garbage contract with Denny's Sanitation as the current 3-year contract expires March 2021.

Stacy Denekas reported to the council that Michael Denekas has already removed two beaver from the Rio Grande. Council agreed for Michael Denekas to submit an invoice to get paid by the city for \$35 per beaver removed. He will continue to work on this project.

Next council meeting will be held February 10, 2021 at 7:00 p.m.

Tiedeman made a motion to adjourn at 8:06 pm. Denekas seconded the motion. All present cast ayes votes, motion carried.
