Council received a resignation from Spencer Sprock, Mowing & Street Help with the last day of employment June 13, 2024. Gruis made a motion to accept the resignation from letter from Sprock. Storm seconded the motion. All present cast aye votes, motion carried.

Council discussed other mowing & street help applicants and wages for the **2024 Summer Help Staff**. Gruis made a motion to hire **Mowing & Street Help** – Austin Eben \$15.00/hour and to hire **Lifeguard** – Maverick Medlin \$14.00/hour. Storm seconded the motion. All present cast aye votes, motion carried.

Fred Landis, Kiwanis member presented to the council the idea to put up a pickle ball court in the old park (Siebring Park). Council will review and discuss further at the July meeting.

Council received a material estimate from CFE-Lumber to repair the pumphouse roof. Gruis made a motion to accept and replace the roof. Gerken seconded the motion. All present cast aye votes, motion carried.

Council discussed the purchase of a 1998 Internation Dump Truck from Mitchell & Huss Excavation in the amount of \$20,000 using Casino Revenue funding for the purchase. Vivian made a motion to approve the purchase. Hamilton seconded the motion. All present cast aye votes.

Council reviewed the request for street closer on the 300 block of E Iowa Avenue for a Blessing of the Bikes event at Ebenezer Presbyterian Church on June 30 from 7am-12pm. Gruis made a motion to allow the street closure for the event. Vivian seconded the motion. All present cast aye votes, motion carried.

Gruis introduced the following **Resolution 2024-06-431** entitled "RESOLUTION OF THE CITY COUNCIL OF GEORGE, IOWA TO CLOSE PORTIONS OF CITY STREETS FOR THE JULY CELEBRATION" and moved that the same be adopted. Vivian seconded the motion to

adopt. Roll call vote –ayes: Gerken, Gruis, Hamilton, Storm and Vivian, –nays: none. Motion carried.

Council reviewed a request for an outdoor event and street closure for Last Call 2 street dance to be held on July 4. Gruis made a motion to allow the street closure and approve the liquor license for the event. Vivian seconded the motion. All present cast aye votes, motion carried.

Council received a peddler permit application was received from Burn Unit BBQ and the request to extend the peddler permit time until Midnight on July 4. Vivian made a motion to allow the extension to the peddler permit for the event. Gerken seconded the motion. All present cast aye votes, motion carried.

Council received a peddler permit application was received from Tropical Sno Cone and the request to extend the peddler permit time until 10pm on July 6. Vivian made a motion to allow the extension to the peddler permit for the event. Gerken seconded the motion. All present cast aye votes, motion carried.

Council received a peddler permit application was received from Taquitos El Toluqueno and the request to extend the peddler permit time until 9pm every Tuesday and Thursday for this year. Vivian made a motion to allow the extension to the peddler permit for the event. Gerken seconded the motion. All present cast aye votes, motion carried.

Council received an Alcohol/Liquor License application renewal for Total Stop. Gruis made a motion to approve the liquor license renewal. Hamilton seconded the motion. All present cast aye votes, motion carried.

Vivian made a motion to renew the ICAP Property Insurance policy. Storm seconded the motion. All present cast aye votes, motion carried.

Next monthly council meeting will be held July 10, 2024 at 7:00 p.m.

Gerken made a motion to adjourn at 7:30 pm. Storm seconded the motion. All present cast aye votes, motion carried.
